Matters not on the posted agenda will be discussed in accordance with the order of the agenda. Speakers should not expect CCPAB members to comment on or respond to comments directly during the meeting. The CCPAB may request county staff to follow up with a speaker or provide additional information after the meeting or at a later date.

The Chairperson, at their discretion, may increase or decrease the time allocation. Each speaker shall limit remarks to the specified time allotment as follows:

- Speakers will have 3-minutes total for each separate item.
- Speakers will have 3-minutes total for any matter not on the posted agenda.

CCPAB Public Comment time limits are consistent with the time limits used by the Sacramento County Board of Supervisors.

The Public Safety and Justice Agency sought the CCPAB's input on the Kevin O'Connell recommendations, programs that should be expanded, and any additional efforts that should be considered to reduce jail population.

Comments provided by CCPAB members included the following:

• The justice system could best serve the jail population by educating them on the justice system.

- During COVID, a mass release was completed. Organizations collaborated with providing necessities and transportation. This could potentially be completed on a larger scale.
- SB1223 was signed into law last week allowing more applications to be processed for Mental Health Diversion.
- Individuals need family support and community support. If communities were
  provided tools and training, they would be able to identify issues that arise,
  deescalate, and contact a community based organization to assist.
- Mental Health Diversion is in need of additional resources. Individuals are waiting approximately 9 months for assessments and 2 months for in custody individuals.
- Elements of Seattle's LEAD model are already present and could be expanded by adding access to Public Defender and community-based organization(s).
- Law enforcement could drop off qualified misdemeanor stops to 711 G Street for the individuals to receive services immediately rather than losing a minimum of 3 months engagement. Currently, the infrastructure isn't set up for this process and would need work done.
- Defendants with warrants have a difficult time getting to the new Sheriff's location compared to when it was easily located at 711 G St.

<u>Public Comment:</u> A public presentation on the O'Connell report could be beneficial as it is a lengthy report. There are 10 monitoring reports on the Mays Consent Decree. The O'Connell report states 40% of the population are for warrant violations and these individuals could be reviewed to reduce the jail population. Also, 30% of individuals are released unhoused and funding could be utilized better to provide services. When speaking on the work force issue, it could also be a pay equity issue and minimum wage issue. Investment in diversions and pre-trial could be beneficial. Individuals who are physically ill or over the age of 50 are not a risk and should be considered for release.

#### 4 – Meeting Logistics

#### Background:

Due to the COVID-19 Pandemic, the Community Corrections Partnership Advisory Board (CCPAB) met online via Zoom through June 2022. In July 2022, the CCPAB began meeting monthly, in person, in the Hearing Rooms at the County Administration Building (700 H Street, Sacramento). Since in person meetings began, attendance at CCPAB meetings has increased. During the October 3, 2022 meeting, it was recommended that the CCPAB consider moving to a larger meeting space. Additionally, it was recommended that the CCPAB consider live-streaming its meetings to allow for greater public participation.

Beginning with the November 2022 meeting, the CCPAB will meet in the County Board of Supervisors Chambers. In-room technology will facilitate live-streaming of meetings, which will be tested in December 2022 with full implementation beginning in January 2023.

During the October meeting, it was suggested that the CCPAB explore an alternative meeting time outside of traditional business hours (such as evenings or weekends) to encourage greater community attendance at CCPAB meetings.

Staff intends to bring forward a 2023 meeting schedule for approval at the next meeting. If the CCPAB desires to change the meeting schedule to a timeframe outside of traditional business hours, staff will need sufficient time to coordinate an alternate schedule and identify a meeting location.

<u>5 – AB 109 Plan 2022 Update Status</u>

#### Recommendation:

Receive information regarding the current status of the AB 109 Plan 2022 Update.

#### Background:

On May 28, 2014, the Board of Supervisors accepted Sacramento County's Long-Term AB 109 Plan. California's Budget Act of 2020 added a new mandate which requires the CCP in each county to submit an updated AB 109 Plan to the Board of State and Community Corrections (BSCC) each year by December 15. Since its formation in 2021, the CCPAB has played an integral role in providing recommendations to the CCP for inclusion in its annual AB 109 Plan updates.

In September 2022, the CCPAB unanimously voted to recommend the AB 109 Plan 2022 Update for consideration by the CCP. The AB 109 Plan 2022 Update was then unanimously approved by the CCP in October 2022. On November 8, 2022, the Chief Yarber, the Chair of the CCP, presented the AB 109 Plan 2022 Update to the Board of Supervisors. Following a vote, the plan was accepted by all Supervisors present (Supervisor Kennedy was not in attendance). Staff may now submit the AB 109 Plan 2022 Update to the BSCC before the December 15<sup>th</sup> deadline.

Staff will work to post the AB 109 Plan 2022 Update to the CCP and CCPAB websites. The plan is also able to be distributed to various departments or interested community members and groups.


#### Recommendation:

a) Receive an update from the Outreach to Justice-Involved Individuals and Families Ad Hoc Committee.

#### **Background:**

The Outreach to Justice-Involved Individuals and Families Ad Hoc Committee was tasked with developing a plan to survey formerly incarcerated individuals on the programs and services they received prior to and after incarceration. The ad hoc committee met weekly and had discussions on the population, programs, services, logistics, resources, and goals of the subcommittee. The ad hoc committee is here today to present a plan to move forward with both a survey and focus groups in the community to identify what services were useful, what services were not useful, what supports the individual had, and what programs and services they perceive to be beneficial for someone with their life experiences. The ad hoc committee's plan preparation process is described in the infographic below.



Below is the outlined plan for review and consideration. Attached are the committee's work plan and draft survey.

#### Timeline:

The ad hoc committee plans to release the survey in January with an end date of March 15, 2023 (sending a reminder on March 1, 2023). The survey will be sent out via email to the committee, community based organizations, and faith based organizations. Those organizations can send the survey to their participants to complete. The committee desires the CCPAB's assistance in identifying a list of organizations (with contact information) to whom the survey should be sent. Please send a list of recommended organizations and contact information to staff (fosterl@saccounty.gov) by November 24<sup>th</sup>.

Upon approval, the subcommittee will meet and discuss logistics and resources to conduct four focus groups beginning in January and concluding by April. By utilizing both a survey and a series of focus groups, the ad hoc committee aims to be able to identify trends and themes that may influence the CCPAB's prioritization for services and programs to include in next year's AB 109 Plan Update.

#### Background:

The Public Awareness Ad Hoc Committee was tasked with producing a plan (or campaign) to expand public awareness and encourage community engagement. The goals and methods associated with the campaign are outlined below.

  - Social media postings will be used periodically and strategically to increase awareness and engagement.
- Develop and present a PowerPoint for community and group meetings.
  - The PowerPoint may be used during community town hall meetings (in person or over zoom), or when presenting to smaller groups or individuals. It may also be posted to the CCPAB website.
- Establish and Maintain a Meeting Material Distribution List.
  - Staff will maintain an email list of those desiring to receive notifications/materials for CCPAB meetings.
  - After each meeting's materials have been posted, staff will send an email notification to all distribution list members.
  - Sign up by emailing SacCountyCCPAdvisoryBoard@SacCounty.gov.
- Ask CCP Executive Committee agencies/departments to post/share the AB 109 Plan Update each year.
- Facilitate increased engagement during meetings.
  - Offer hybrid/virtual attendance options for members of the public interested in participating in CCPAB meetings.
  - Consider moving to a larger space for meetings that can accommodate greater public attendance.

# Frequently Asked Questions

#### What is AB 109 (Public Safety Realignment)?

In 2011, the California Legislature and Governor passed sweeping public safety legislation that effectively shifted responsibility for certain populations of offenders from the state to the counties. The California Public Safety Realignment Act of 2011 (known as AB 109) allows for non-violent, non-serious, and non-sex offenders to be sentenced or placed on community supervision at the local County level. AB 109 required each County to have a Community Corrections Partnership to develop an AB 109 implementation plan to address responsibilities for realigned offenders going through the local justice continuum. The Community Corrections Partnership must update its plan annually to be eligible for continued funding.

#### What is the CCP Advisory Board (CCPAB)?

The CCPAB advises the Sacramento County Community Corrections Partnership on its annual plan updates regarding public safety realignment to maximize the effective investment of criminal justice resources. The CCPAB's recommendations are based on community input and ongoing data collection, evaluation, and analysis aimed at maintaining and improving community safety, reducing recidivism, and decreasing the use of the jail through expansion of community based treatment and support services.

#### Who are the CCPAB's Members?

The CCPAB was developed to promote community engagement and encourage public input into the plan. The CCPAB consists of four appointed community members, including justice-involved individuals, as well as a collaborative group of representatives from Sacramento County justice system agencies.

## Overcrowding in California Prisons and the Enactment of AB 109

*Brown v. Platt*, (2011) 563 US 493, California Supreme Court found confinement conditions in the California Department of Corrections (CDCR) unconstitutional due to over crowding.

- In response to this Supreme Court decision, the State of California passed Assembly Bill 109, The Public Safety Realignment Act.
- ▶ AB 109 diverted individuals convicted of certain crimes from CDCR to remain in county jail and under community supervision.

#### Enactment of AB 117 and the CCPAB

Along with AB 109, the legislature passed AB 117. AB 117 requires every County to create a Community Corrections Partnership (CCP). The CCP is required to develop an AB 109 plan update each year.

- ▶ In February 2021, the CCP developed the CCP Advisory Board (CCPAB) to develop recommendations to the CCP for annual updates to the AB 109 Plan based on community input and ongoing data collection, evaluation, and analysis.
- ► The CCPAB includes a representative from District Attorney, Public Defender, Probation, Superior Court, Sheriff, Sacramento Police Department, Social Services, and four community members.

## Responsibility of the Sacramento County Community Corrections Advisory Board

The responsibility of the CCPAB is to:

- ▶ Understand the AB 109 population
- Listen to community and justice partners on the needs of the AB 109 population
- ▶ Evaluate data and research new evidence-based programs and services
- Recommend updates to the Sacramento County CCP for improvements to the AB 109 Plan that responds to the needs of Sacramento County AB 109 population

#### Goals of the CCPAB

The goals of the CCPAB includes developing recommendations for AB 109 plan updates that:

- Maintain and improve community safety
- Reduce recidivism
- Decrease the use of jail through expansion of community based treatment and support services

## Understanding the AB 109 population

The AB 109 population includes individuals who were convicted of a non-serious, non-violent, and non-sex felony offense. Instead of these individuals serving time in prison, they will serve time in our Sacramento County jail. Once released from jail, they will be supervised by the Sacramento Probation Department. Historically, the needs of this population include:

- Homelessness
- Substance Use
- Mental Health

#### **Background:**

Each year, each county's Community Corrections Partnership (CCP) is required to submit an updated AB 109 Plan to the Board of State and Community Corrections (BSCC) by December 15. Since its formation in 2021, the CCPAB has played an integral role in providing recommendations to the CCP for inclusion in its annual AB 109 Plan updates. To facilitate the development of the AB 109 Plan 2023 Update, staff has coordinated with the Chair and Vice Chair to develop a Workplan for the CCPAB's consideration.

#### The Workplan includes:

- Receiving a training/refresher on the Brown Act.
- Receiving presentations from CCPAB Member Departments (See Attachment 1 Presentation Guidelines).
- Providing and soliciting frequent feedback to and from CCP on CCPAB activities/recommendations.
- Reviewing Available Data on AB 109 Plan Priorities (priorities identified in the current approved plan; in this case, the 2022 Update).
- Establishing a "2023 Plan Documentation" Ad Hoc Committee to draft written content and make editing suggestions for the CCPAB's approval.
- Prioritizing programs and services for inclusion in the 2023 Plan Update.
- Producing early 2023 Plan Update drafts for community input (first draft to be produced in June 2023).

"In 1994, John Ehrlichman, the Watergate co-conspirator, unlocked for me one of the great mysteries of modern American history: How did the United States entangle itself in a policy of drug prohibition that has yielded so much misery and so few good results? ...

"You want to know what this was really all about?" [Ehrlichman] asked with the bluntness of a man who, after public disgrace and a stretch in federal prison, had little left to protect.

"The Nixon campaign in 1968, and the Nixon White House after that, had two enemies: the antiwar left and black people. You understand what I'm saying? We knew we couldn't make it illegal to be either against the war or blacks, but by getting the public to associate the hippies with marijuana and blacks with heroin, and then criminalizing both heavily, we could disrupt those communities.

We could arrest their leaders, raid their homes, break up their meetings, and vilify them night after night on the evening news.

Did we know we were lying about the drugs? Of course we did.""

#### **Crime Rates & Trends**

Many ordinary citizens reportedly feel concerned about increased crime in recent months, yet often lack a realistic perspective on the situation. While there have been slight increases in rates in recent months, the overall rates are substantially lower than those in the late 1980s and the early 1990s.

Another important point is to differentiate between violent crime, and economic crime such as theft, whether burglary or trashing homeless people's belongings. Most violent crime occurs between people who are previously acquainted; stranger danger is the exception.

This video lecture - YouTube.com/watch?v=L4j6PzwmFgc - about psychopathy and brain anatomy, by the forensic psychiatrist, Dr. Octavio Choi, informs viewers that:

About 1% of men and 20% of male inmates are psychopaths, and half of all violent crime is committed by this small portion of the population. Perhaps 0.2% of women are psychopaths. The PCL-R, in conjunction with qualitative interviews, is designed to identify psychopathic people who are the most likely source of stranger danger for violent crime.

Citizens who have a good understanding of how to identify psychopathic behavior can better protect themselves. Cops can directly prevent only a small number of crimes; it's the strength of a community that is most effective in suppressing abusive behavior of all kinds.
