Speaker time limits

In the interest of facilitating the conduct of CCPAB business, members of the public (speakers) who wish to address the board during the meeting will have specific time limits as enumerated below. Matters not on the posted agenda will be discussed in accordance with the order of the agenda. Speakers should not expect CCPAB members to comment on or respond to comments directly during the meeting. The CCPAB may request county staff to follow up with a speaker or provide additional information after the meeting or at a later date.

The Chairperson, at their discretion, may increase or decrease the time allocation. Each speaker shall limit remarks to the specified time allotment as follows:

- Speakers will have 2-minutes total for each separate item.
- Speakers will have 2-minutes total for any matter not on the posted agenda.

In-Person Public Comment

Speakers will be required to complete and submit a speaker request form to staff. Staff will invite each individual to the podium to make a verbal comment.

Zoom Public Comment

Members of the Public participating through Zoom should observe the following procedures when providing public comment. Comments submitted through the "Chat" feature will not be accepted. If you wish to speak on an item, click on "raise hand" after the item has been called. When it is your turn to speak, your name or telephone number will be called and you will be able to address the body. Please be sure your device is not muted. If you raise your hand after public comment has been closed, you will not be called.



#4 - Appoint Andy Soloman to CCPAB Ad Hoc Committee Ad Hoc Committee Dedicated to Developing an Understanding of Racial Disparities Within the AB 109 Population and Populations Served by AB 109-Funded Programs

Recommendation:

Staff recommends the Community Corrections Partnership Advisory Board (CCPAB) appoint Andy Soloman to the Racial Disparities Ad Hoc Committee.

Background:

In December 2023, the CCPAB established an ad hoc committee dedicated to developing an understanding of racial disparities within the AB 109 population and populations served by AB 109-funded programs. CCPAB ad hoc committees are limited to 5 members to avoid reaching a quorum. The approved membership for the committee included CCPAB Members Lacey, Davis, Baker, Jeremiah, and Howland. Since the committee's formation, Robyn Howland changed work assignments and no longer serves on the CCPAB, rendering her ineligible to continue with the ad hoc committee and creating a vacancy within the committee. Since Member Howland's departure, Member Andy Soloman expressed interest in serving on the committee. Staff seeks approval to add Member Soloman to the committee.

#5 - Discussion and Possible Approval of Strategy to Develop a Definition of Community Safety for the AB 109 Plan 2024 Update

Recommendation:

Staff recommends the Community Corrections Partnership Advisory Board (CCPAB) approve the proposed strategy to receive community input necessary to draft a definition of Community Safety for the AB 109 Plan 2024 Update.

Background:

One of the goals for the County's AB 109 Plan is to maintain and improve community safety. Currently, this is only being measured using crime rates. In its AB 109 Plan 2023 Update, the CCP and CCPAB recognized that it will be necessary to define community safety in order to develop objectives that are specific, measurable, achievable, realistic, and time-bound. To avoid developing a definition in a vacuum, and recognizing that public participation in CCPAB meetings is generally low, staff met with the CCPAB executive committee to develop a proposal for receiving additional community input on this topic.

Rather than asking the public to come to the CCPAB meetings, it was suggested that greater input would be received by going to the different County boards and commissions where there is a direct nexus or substantial interest in the issue of community safety. It is suggested that staff and at least one CCPAB member request time on different meeting agendas to briefly discuss the topic of community safety. To ensure that information is collected in a manageable and consistent manner, each presentation would focus on the following three questions:

- 1) What is something that causes you feel safe in your community?
- 2) What is something that causes you feel unsafe in your community?
- 3) If you could do one thing to make your community a safer place, what would it be?

Making Conflict Work: Harnessing the Power of Disagreement

Peter T Coleman, professor of psychology and education, and Robert Ferguson, psychologist and executive coach, have co-authored this very helpful book for those wishing to speak truth to power. Specifically, they focus on conflict between people with differing levels of organizational and/or hierarchical power, as well as conflict between equals which already enjoys a wide literature.

They posit 7 basic strategies: benevolence, support, dominance, appeasement, autonomy, adaptivity, and/or rebellion, and 3 traits of conflicts: intensity, structure and transparency.

"The intensity of the conflict was the biggest predictor of the types of behaviors between the parties: the higher the intensity of the conflict, the more unfriendly and disrespectful their behavior. The degree to which the disputants shared common goals was the biggest predictor of whether they'd reach an agreement. The more explicit the issues in the conflict, the more the disputants viewed the mediation process as fair and the more likely they were to find a resolution."

Economic Insecurity in the USA

Recently, a C-SPAN program informed me about ALICE - namely, the 40% of the U.S. population who are "asset-limited, income-constrained, employed." These are the people who are most likely to end up homeless because they don't have \$500 to deal with a common emergency such as a health crisis, major car repair, divorce, eviction, etc.

United for Alice is a national organization that began a decade ago "as a study to understand the struggles of families in one New Jersey county. This body of research has worked to increasingly shed light on a hidden population we now know as ALICE." United for Alice's focus on economic data has led to a more relevant analysis than the Consumer Price Index, namely, "the ALICE Essentials Index [which] measures the cost increase of household basics only."

I emailed them and learned that they "have limited data for California, but there is data available. You can hover over California on the page below and see the overall statewide and county numbers. We do not produce Household Survival Budgets for the state as they are not currently a partner state. See here: <u>https://unitedforalice.org/national-overview</u>"
